7. Beneficiary farmer who take water from WUA will pay water tariff as per the rate fixed by the WUA/Irrigation and Water Resources Department (IWRD).
8. I/We undertake that I/We will abide by furnished undertaking regarding %age coverage of on farm M.I.(Drip/Sprinkler) for minimum period of 7 years.

9. I/We read all the relevant policies of MICADA and laid down rules/regulations of government. I/We voluntarily undertake that I/We will abide by all of them.

10. I/We agree to pay my/our contribution towards construction of watercourse in accordance with watercourse policy. I/We also agree to accept prevailing subsidy regarding On- Farm MI, Solar Pump and On-Farm Pond at the time of execution of work.
